In consideration of the services of A & L Outfitters and being permitted to access lands owned, leased or controlled by A & L Outfitters, the rate charged for those services and the right to engage in the events as a participant and /or volunteer, I, for myself, my heirs and personal representatives, do hereby fully and forever release, waive and discharge and covenant not to sue A & L Outfitters and others associated therewith, including but not limited to its managers, members, employees or agents and all persons whomsoever, directly or indirectly, liable or alleged to be liable for any or all claims, demands, actions, causes of action, damages, costs, loss of services, expenses (including attorney fees) and all other claims of damage whatsoever and of whatever nomenclature, both in law and in equity, on account of or in any way resulting from personal injuries, conscious suffering, death or property damage sustained by me and arising out of or associated with my accessing lands owned, leased, or controlled by A & L Outfitters of from any activities associated with the services of A & L Outfitters or my use of property owned, leased, or controlled by A & L Outfitters including, but not limited to all claims for negligent acts and excepting only injury of death resulting from willful misconduct.

I covenant and agree to assume the full responsibility for and risk of bodily injury, death or property damage relating to my activities, those of A & L Outfitters and the use of property owned, leased, or controlled by A & L Outfitters and expressly agree that this release is intended to be as broad and inclusive permitted by the laws of the state of Wyoming.

If further covenant and agree to indemnify and hold harmless A & L Outfitters and all others associated therewith, including but not limited to its managers, members, employees or agents and all other persons whomsoever, directly or indirectly, liable or alleged to be liable from any and all claims, demands, actions, causes of action, damages, costs, loss of services, expenses (including attorney fees) and all other claims of damage whatsoever and of whatever nomenclature, both in law and in equity, on account of or in any way resulting from personal injuries, conscious suffering, death of property damage sustained by me and arising out of or associated with my accessing lands owned, leased, or controlled by damages, costs, loss of services, expenses (including attorney fees) and all other claims of damage whatsoever and of whatever nomenclature, both in law and in equity by me and arising out of or associated with my accessing lands owned, leased, or controlled by A & L Outfitters of from any activities, including but not limited to all claims for negligent acts and excepting only injury of death resulting from willful misconduct.
